- 1. We, Dragon Mount Development Limited, refer to your purchase of the Property under a preliminary agreement for sale and purchase (the "Preliminary Agreement") dated the date hereof.

All the rights and remedies of the Vendor under the Preliminary Agreement and the Agreement for Sale and Purchase shall not be affected by this letter. Nothingin this letter shall in any way prejudice, vary or affect the operation, validity or enforceability of the Preliminary Agreement or the Agreement for Sale and Purchase, or the rights, duties or obligations of the parties to the Preliminary Agreement or the Agreement for Sale and Purchase.

印花稅須知 Note on Stamp Duty

The Government announced that the Stamp Duty Ordinance would be amended to <u>cancel all demand-side management measures for residential properties with effect from 28 February 2024</u>, that is, no Special Stamp Duty ("SSD"), Buyer's Stamp Duty ("BSD") or Ad Valorem Stamp Duty ("AVD") at 7.5% under Part 1 of Scale 1 needs to be paid for any residential property transactions starting from that day. The Government will introduce the Stamp Duty (Amendment) Bill 2024 ("the Bill") into the Legislative Council to take forward the proposal. The Chief Executive has also made the Public Revenue Protection (Stamp Duty) Order 2024 under the Public Revenue Protection Ordinance (Cap. 120) to give full force and effect of law to the Bill before its enactment.

Subject to the eventual enactment of the Bill, any instrument executed on or after 28 February 2024 for the sale and purchase or transfer of residential properties are no longer subject to SSD and BSD. The AVD rate of 7.5% under Part 1 of Scale 1 is to be amended to the same as those of AVD at Scale 2.

政府宣布將修訂《印花稅條例》,<u>由2024年2月28日起撤銷所有住宅物業需求管理措施</u>,即由該天起所有住宅物業交易無須再繳付「額外印花稅」、「買家印花稅」和第1標準第1部之下 7.5% 的「從價印花稅」。政府將向立法會提交《2024年印花稅(修訂)條例草案》(《條例草案》)以落實該建議。行政長官亦已根據《公共收入保障條例》(第120章)作出《2024年公共收入保障(印花稅)令》,使《條例草案》在制定成法律前具有十足法律效力。

在《條例草案》最終獲立法會通過的前提下,任何在2024年2月28日或以後所簽立以買賣或轉讓住宅物業的文書均無須徵收「額外印花税」和「買家印花税」。第1標準第1部之下 7.5% 的「從價印花稅」稅率將修訂為與第2標準的稅率相同。
